The Management of the Company is responsible to ensure the compliance of the requirements of the Act, Rules and circulars issued by Ministry of Corporate Affairs and SEBI relating to remote e-voting and e-voting during the $40^{\text {th }}$ AGM on the proposed resolutions contained in the Notice. My responsibility as a Scrutinizer for the process of voting through remote e-voting and e-voting during the $40^{\text {th }} \mathrm{AGM}$ is to ensure that the voting process is conducted in a fair and transparent manner and is restricted to making a Scrutinizer's Report for the votes cast in "favour" or "against" on the resolutions proposed in the Notice, based on the reports generated from the e-voting system provided by Central Depositories Services (India) Limited (CDSL), the agency authorized under the Rules and engaged by the Company, to provide platform for voting through remote evoting and e-voting during the $40^{\text {th }}$ AGM and platform for VC/OAVM facility for participation in the $40^{\text {th }}$ AGM.

As mentioned in the Notice the proceedings of the AGM were deemed to be conducted at the Registered Office of the Company and the same was deemed to be the venue of AGM.

I do hereby submit my Report as under:-
(i) The Company had appointed Central Depositories Services (India) Limited (CDSL) as the service provider, for the purpose of extending the facility of Remote E-Voting to the Members of the Company and for voting electronically at the meeting.
(ii) Ankit Consultancy Private Limited is the Registrar and Transfer Agent ("RTA") of the Company.
(iii) CDSL had provided a system for recording the votes of the Members electronically through remote e-voting as well as at the meeting on all the items of the businesses sought to be transacted in the $40^{\text {th }}$ AGM of the Company, which was held on Friday, 29th September, 2023.
(iv) The voting rights were reckoned on Friday, 22 ${ }^{\text {nd }}$ September, 2023, being the cut-off date for the purpose of deciding the entitlements of members at the remote e-voting and voting during the $40^{\text {th }}$ Annual General Meeting.
(v) Remote E-Voting platform remained open from Tuesday, $26^{\text {th }}$ September, 2023 (9.00 A.M.) up to Thursday, $28^{\text {th }}$ September, 2023 ( 5.00 P.M.) and members were
given an option to cast their votes electronically conveying their assent or dissent in respect of the Resolutions on the e-voting platform provided by CDSL.
