**COUNTING UNDERWAY** | Will accept results if elections are free and fair, say BNP, Jamaat chiefs; no 'boat' symbol on ballot for the first time in 30 years

# Bangladesh votes in crucial poll

The counting of votes was underway on Thursday after Bangladeshis cast ballots in the crucial general election to elect a new government to replace the interim administration, which took charge after the collapse of the Awami League regime in August 2024. The voting for the 13th parliamentary elections was held along with a referendum on the implementation of a complex 84-point reform package, known as the July National Charter.

The counting of votes began after voting concluded at 4.30 pm. In places where voters were in line inside the polling station, voting continued until "The first significant results may be available overnight," an EC spokesman said.

The election is considered a direct contest between the Bangladesh Nationalist Party (BNP) and its once ally Jamaat-e-Islami, in the absence of ousted PM Sheikh Hasina's now disbanded Awami League.

Chief Adviser Muhammad Yunus' interim government last year disbanded the Awami League and barred it from contesting the polls. It is for the first time in 30 years, the election symbol of Hasina's Awami League 'boat' has not appeared on the ballot paper.

In total, the boat symbol has been absent from the ballot paper in three of Bangladesh's 13 parliamentary elections.

Since the introduction of the political party registration sys-

tem in 2008, a total of 63 parties have been registered. Of these, registration of three parties has been cancelled, while one remains suspended this year. Of the remaining 59 registered parties, 51 are contesting the 13th parliamentary election. Including both party-nominated and independent candidates, there are a total of 2,009 candidates across 299 of the 300 parliamentary constituencies. The election in one constituency was cancelled due to the death of a candidate. Nearly 127 million voters were registered to cast their ballots, including five million first-time voters, in 42,779 polling centres.

Election Commission Senior Secretary Akhtar Ahmed said around 48% voter turnout was

recorded till 2 pm nationwide. Soon after voting concluded, Chief Adviser Yunus thanked people for the participation in the general election and the referendum.

"We will move forward collectively towards building an accountable, inclusive and justice-based state," he said. "Let's work together in this journey to strengthen democracy." Yunus earlier described the elections and the referendum as a historic opportunity to build a "new Bangladesh".

Earlier, top leaders of both BNP and Jamaat raised fears of manipulation and said they would accept the results of the elections if they are held in a "free, fair, impartial manner".

Bangladesh's deposed PM Sheikh Hasina said, "The people's voting rights, democratic values, and the spirit of the Constitution were completely disregarded in this deceptive, voterless election conducted without the Awami League." From the evening of Feb 11, this farce began with seizure of polling centres, gunfire, vote-buying, distribution of money, stamping of ballots, and agents signing result sheets," she alleged. As per EC's briefing, by 11 am, just three and a half hours into voting, only 14.96% of eligible voters had participated. "This extremely low turnout shows Awami League's 'free election was widely rejected by people."

his vote at the Gulshan Model School and College centre in Dhaka's upscale Gulshan, said he was "confident" his party would regain power after over 15 years of political wilderness, but demanded the results be timely released.

"If the election is held in a free, fair, impartial manner and without controversy, then why shouldn't we accept it? We will accept it. However, of course, there is one condition the election must be impartial and peaceful," the 60-year-old leader said. Shafiqur Rahman, the chief of right-wing Jamaat-e-Islami, leading an II-party alliance, said his party would accept the election results if the polls were held in a "free and neutral manner".
